The Bay of Bengal Programme Inter-Governmental Organisation (BOBP-IGO) is offering two vehicles for scrap auction that are no longer in operational use. Sealed tenders are invited to participate in scrap auction of the used vehicle on '**AS IS WHERE IS BASIS**'. The rates may be quoted as per the description of the Vehicle mentioned in Annexure 'A' annexed hereto. Interested parties for inspection and other details in respect of the said vehicles, if they so desire, may contact Admin Officer, BOBP-IGO, on any working day between 11.00 AM to 4.30 PM except on Saturday/Sunday & Holiday for any further information about the said used vehicles before quoting the rates.

### **A-INVITATION OF TENDER:**

**A-1-**Two (2) separate sealed envelopes should be used for submitting the Tender Document and Earnest Money. Envelopes should be super scribed (a) 'PRICE BID for SCRAPPING of USED VEHICLE" and (b) "Earnest Money for SCRAPPING OF USED VEHICLE" respectively.

**A-2-**The tenderers are expected to examine all the instructions, Proforma's terms & conditions, and specifications in the tender documents. Failing to furnish all information required by the tender document in any respect will be at the tenderer's risk and may result in the rejection of the tender.

**A-3-**The tender must be received not later than the date & time specified for submitting the same. In case, the date of submitting the tender will be declared as holiday by the BOBP-IGO, then next working day will be treated as due date of tender at the same time. The tenders received after due date and/or time and/or without Earnest Money will not be entertained

**A-4-**Interested parties may send their sealed tenders in two separate sealed envelopes, one containing (i) "Tender Document" along with bidders' details and EMD details and another containing (ii) "Financial Bid" superscribing on the envelopes respectively. Both the envelopes should then be put in an outer cover indicating thereon:

**A-5-**The payment of Earnest Money should be made through Demand Draft from any scheduled commercial bank, drawn in favour of Director, BOBP-IGO, payable at Chennai and a copy of the transaction should be enclosed in the envelope.

**A-6-**In the first instance, envelopes containing Earnest Money and tenders will be opened.

## **B. TERMS AND CONDITIONS OF TENDER**

**B-1-**The Tenderers are required to quote their highest rate of the vehicle mentioned in **Annexure 'B'** annexed hereto. The bid will be confirmed in favour of the person quoting the highest rate in respect of the vehicle. Bid price quoted below the reserve price shall be rejected and the EMD of such bidders shall not be returned.

**B-2-**The tenderers are required to send their rate along with single payment of Earnest Money of **Rs. 4100/-(Rupees Four thousand one hundred only)** through demand draft for the vehicle. The Earnest Money will be refunded to the unsuccessful tenderer on their written request with respect thereto. Name of the firm/individual, telephone no. and address may be indicated on the reverse side of the Demand Draft. The EMD of successful bidder shall be adjusted against the bid price. EMD against modified, withdrawn, altered and conditional bids shall not be returned.

**B-3-**The rates should be valid for a minimum period of **30 days** from the date of opening of price bid.

**B-4-**Hypothetical or conditional bid will be rejected. Bids once submitted shall not be allowed to be withdrawn or altered. If the bidder is withdrawn or altered by the concerned party at any time after it is submitted, EMD amount shall be forfeited.

**B-5-** The BOBP-IGO administration will deal with the bidder directly and no middle-men/ agents/ commission agents etc., should be asked by the bidder to represent their cause and they will not be entertained by BOBP-IGO.

**B-6-**Over-writing/over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the bid invalid.

**B-7-**The BOBP-IGO reserves the right to make any change, at any time, to the terms and conditions of the Notice Inviting Tender and accept or reject any or all bids wholly or partly without assigning any reason thereof.

**B-8-**The bidders have to quote the rates at **Annexure 'B'** both in figures and word corresponding to the vehicle. Bid price below the reserve price shall be rejected.

**B-9-**Bid Document including the documents submitted therein must be duly signed/ stamped on all pages failing which the offer shall be liable for rejection

**B-10-**Each bidder has to certify that all the terms and conditions are acceptable to him. The Earnest Money shall stand forfeited in case of breach of any of the conditions mentioned in the bid document.

**B-11-**It is obligatory on each bidder that one person who desires to bid, should quote for the item as mentioned in the Annexure 'A' enclosed herewith. Used vehicles to the successful bidder shall be released only after depositing full and final payment with BOBP-IGO in shape of Demand Draft from any scheduled bank drawn in favour of Director, BOBP-IGO, payable at Chennai.

**B-12-** Bidder may choose to bid for one or both the car. The bidder quoting the highest price will be considered as successful bidder. BOBP will reserve the option to negotiate the price with the bidder as deemed.

**B-13-**No bidder shall be permitted to bid for vehicles for an amount less than the reserve price of the particular vehicle as mentioned below:

**B-14-**BOBP-IGO reserves the right to accept or reject the tender without assigning any reason thereof.

**B-15-**To be eligible for bidding, the bidder shall, along with depositing the earnest money, submit a written bid in closed cover in Proforma (Annexure 'B') to purchase the scrap of the used vehicle. The written bid shall not be less than the reserve price of the used vehicle, but may be more than that.

### **C. TERMS AND CONDITIONS FOR SUCCESSFUL TENDERER**

**C-1-**The successful bidder shall get the vehicle scrapped as per rules, at his own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose as per the applicable Laws of India and submit such documents (CD/CVS) as required under the laws to BOBP-IGO. BOBP-IGO shall not (in any manner) be concerned with or responsible for scrap (used vehicle) and will have no liability whatsoever after the delivery (scrap of used vehicle) to the successful bidder.

**C-2-** The delivery of the scraped vehicle will be arranged only after the successful bidder submits documentary evidence in the support of residential status (PAN Card, Aadhar Card, etc. in case of individual and Registration Certificate, etc. in case of firms).

**C-3-** In the event of acceptance of Tender, the successful bidder shall be required to deposit full amount in the shape of Demand Draft (DD) drawn in favour of the **Director BOBP-IGO, payable at Chennai** within 07 days from the issue of order, failing which the Scrapping order shall be cancelled and EMD will be forfeited, and the bidder will be barred from participating in future and the vehicle will be offered to the second highest bidder.

**C-4-** The interested bidders will submit their bid application along with the copy of self-certified KYC documents (Aadhar card, Pan Card, Latest Address proof, active bank statement etc.)

**C-5-** BOBP-IGO, in its discretion, reserves the right to reject or accept any bid, partly or completely, at any time without assigning any reason, therefore. The decision of BOBP-IGO in this matter shall be final.

**C-6-** Disputes, if any, shall be subject to jurisdiction in the Court of Chennai only.

**C-7-** The successful bidder shall take away the scrapped vehicle, at his own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. BOBP-IGO shall not in any manner be concerned with or responsible for these vehicle, and will have no liability whatsoever after the issue of delivery order of said items to the successful bidder.

**C-8-** Conditional bid will be rejected. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money deposited by him shall stand forfeited.

**C-9-** In case of default of any conditions stated in regard to, by the successful bidder during the period of their engagement, the earnest money shall stand forfeited without any further notice of opportunity.

**C-10-** It shall be presumed that the bidder has fully inspected the used vehicle before the Scrapping. BOBP-IGO shall not be responsible and shall not entertain any complaint in respect of the said vehicle subsequently.
